There is much to learn and summer work is required. This set of papers includes assignments that will be scored once the school year 2019 -20 gets underway.

Assignment guidelines:

- Unless otherwise noted, all assignments should be typed, double spaced, Times New Roman font (12p), 1” margins.
- Work submitted electronically needs to include **your name and assignment title** as part of the file name; this facilitates organization and grading on my end. Thanks.
- Please do not cut and paste information from other sources, particularly the Laws and Treaties section. Use your own words. **Plagiarism will not be tolerated.**

The following are work to be done by our first class meeting. Each will be scored as

1. **(Formative Assessment) Send me a “Letter of Introduction” (aim for 1 page, Word doc email attachment)** including, but not limited to:
  - a. Your full name and what you prefer to be called.
  - b. Who you are and what are your interests?
  - c. Why are you taking APES?
  - d. What are your previous and concurrent math and science courses?
  - e. What are your college and career aspirations?
  - f. Anything else you think I should know – hobbies, family, sports, clubs, etc.
2. **(Performance Assessment) Prevent NDD (nature deficit disorder).** I challenge you to reduce your NDD by getting outside, examine your environs and relate your observations to an audience. You are to **select one** of the following options as a product to report your findings:
  - Collect images of your habitats, of the often over-looked parts too. The images must be captioned and your original work. 10 to 15 images, at least 7/10 or 11/15 must be of the outdoors.
  - Create your own glossary of nouns, verbs, and adjectives of your habits and habitats. Again, 10 to 15 terms with part of speech and definition; at least 7/10 or 11/15 relating to the outdoors.
  - Develop a public service announcement (PSA) or information campaign to help others deepen their appreciation for the value of natural capital, or to care for our natural resources.

### 3. (Homework Assignment ) Laws and Treaties – A summary of each listed Law or Treaty

Make a summary table or spreadsheet of each of the following Laws and Treaties, to include:

- Name of Law or Treaty
- Year Enacted; Year Amended, if applicable
- International or American?
- Describe the function or intent of the law (what is it intended to do?)
- Name the Agency or Group responsible for regulation and enforcement – (i.e. U.N., Department of Interior, EPA, etc.)
