Mr. Robinson reported that the CCIU Board met at the TCHS Pickering Campus, on March 23, 2022. Dr. Kirk Williard, director of career, technical and customized education, introduced Mrs. Erin Petters, principal of TCHS Pickering and Assistant Principal, Dr. Patricia Binkley who gave a presentation on "What Does Career & Technical Education Mean to You?" Mrs. Petters and Dr. Binkley began with a video made by our students in the Digital Media and Sound Communication program. Students spoke about what CTE means to them.

REPORT OF CHESTER COUNTY INTERMEDIATE UNIT AND TECHNICAL COLLEGE HIGH

After the video, Mrs. Petters and Dr. Binkley spoke about the TCHS connections, the hands-on experiences and the various career pathway opportunities afforded to the students who attend TCHS Pickering.

Mr. Joseph Lubitsky, director of administrative services, reviewed in first reading, the draft 2022-23 Marketplace budgets to the Board members and answered questions. The CCIU Board will vote on the Marketplace budgets on April 20. A key point made by Mr. Lubitsky was that the cost of Marketplace programs for purchase by Chester County school districts would increase 2.47%, which is below the Act 1 Statewide Index of 3.4%. School districts are only invoiced for actual services provided. There are 101 programs projected to run in the 2022-23 school year, which operate through our Marketplace Budgets.

On Wednesday, March 23, 2022, two Pennock's Bridge TCHS Animal Science students: Isabella Pontillo (grade 12, Homeschooled/Oxford), and Daniella Ornelas-Rosales (grade 12, Oxford) gave a presentation titled "The Great Grow." The students presented their research study on the nutrition and health of rats to staff members and parents. The purpose of study to observe how changes in the diet affects overall nutrition and health of rats. The students explained the purpose of the experiment, the test methodology and the steps involved in data collection. After presenting research findings the group discussed implications of the results on their hypothesis, the obstacles they faced and how the results of their findings may translate to research findings with people.


