General Fund Proposed Final Budget	Mr. Cooney presented the Proposed Final General Fund Budget for 2023-2024 to the Board. The increase in the Budget for 2023-2024 is \$ 2,558,172 or 3.2 percent. This includes the ESSER expenditures of 3.2 million. If a tax increase is approved at the recommended 4.1 percent increase, the average tax payer will see an increase of around \$183.
