Mr. Robinson stated the Chester County Intermediate Unit Board of Directors did not meet in December.

The Chester County Intermediate Unit was established in 1971, over fifty years ago.

The CCIU serves students from all twelve school districts in Chester County. This past school year, the CCIU offered eighty-four total programs and had seventy-five participants. The CCIU worked with a budget of \$308,309,976 in the 2021-2022 school year.

Brandywine Virtual Academy was started a few years ago by Mary Jeanne Curley. The initial enrollment was a few dozen students. Today there are nearly twenty-one hundred students enrolled.

The next CCIU Board of Directors meeting will be held on Wednesday, January 18, 2023, at 7:30 p.m. at the Educational Service Center, 455 Boot Road, Downingtown, PA.

Mr. Kloss reported that the Legislative Council did not meet in December. The next meeting will be January 25, 2023.

LEGISLATIVE COUNCIL REPRESENTATIVE

The committee met on January 10, 2023. A scoreboard for the baseball ATHLETICS AND STUDEN field is scheduled to be installed. A scoreboard for the softball field is in the works.

ACTIVITIES

Crosswalk signage for Hopewell and radios for the School Resource Officers were discussed.

FACILITIES AND SAFET

Capital Projects that were scheduled for Penn's Grove are almost completed.

Plans to repair the roof at the High School are scheduled for the spring, and the Health Inspection for the HS Bathrooms passed. Furniture in Nottingham's Gym has been removed, and the softball fields should be completed by spring.

Mrs. Kehs stated that the committee held a planning meeting on January EDUCATION COMMITTEE 17, 2023. The next meeting will be held on Monday, February 27, 2023, 4:15-5 p.m. at Hopewell in the LGIA Room. There will be a standing recap meeting at 6:50-7 p.m. prior to each Regular Meeting of the Board.

The committee will only meet during the school year.

Mr. Tenga stated the committee met on January 17, 2023. It is recommended that we opt out of increasing taxes above the Act 1 Index. COMMITTEE the Act 1 index is 5.7%.

BUDGET AND FINANCE

The PSERS contribution rate has gone down.

The committee recommends that the Board pass the Charter Reform Resolution at the February meeting. Charter Schools, even the virtual ones, cost the district, substantial amounts of money. The resolution will prompt the legislature to look at the funding formula which determines the amount of money districts pay to the Charter Schools.

POLICY COMMITTEE

Mrs. Harrison reported that the Policy Committee met and Policy 4410 is on tonight's agenda for a second reading.

Miss Emily Koza reported that All schools have off Monday, January 23, STUDENT 2023. Jordan Bank has the American Heart Association: Kids Heart REPRESE Challenge on January 18, 2023, along with an open house for the parents REPORT Of prospective kindergarteners from 4:00-6:00 p.m. They will be hosting the Oxford Reading Club on Wednesday, January 18, 2023, from 6-7:30 pm.

STUDENT REPRESENTATIVE'S REPORT

Elk Ridge will be having Parent Conferences on January 31, 2023, and February 7, 2023 from 4 to 7:30 P.M. First graders enjoyed a trip to Penn's Grove auditorium to see The Polar Express before the holiday break. Students and staff will be encouraged to wear Red on February 3, 2023, to celebrate American Heart month. All students have been working diligently in completing their mid-year assessments.

December was a month of giving for Nottingham. Under the direction of Nottingham's Gifted Teacher, Mrs. Shelley, students from the Academic Talented Program, sponsored a Food Drive for the community. Nottingham students collected 1,539 food items and donated to the Community Food Box Program, which is coordinated by the Oxford Presbyterian Church and Neighborhood Services Center. The ATP students assisted through commercials on Nottingham News, as well as sorting and packing the items for pick-up.

Nottingham students and teachers also donated toys, household items, and children's clothes during a Holiday Gift Drive. All gifts collected went to the Oxford Borough Neighborhood Services Christmas room to support families in need during the holidays.

Grade 4 students and teachers attended a Field Trip to the Winterthur Museum, Garden and Library, in Winterthur, Delaware. Students had an opportunity to learn about nature and the environment by touring the gardens and a guided tour of the enchanted woods and exhibitions.

The Nottingham Students and staff also participated in the annual winter holiday door decorating contest. Nottingham would like to announce that the 2022-2023 Grade 3 and 4 Envirothon Team has been selected. The team is coached by Ms. Kristen Ciaccia and Mrs. Karen Randall. The team has already started to train afterschool in preparation of the county wide competition in May. This past year over 100 Grade 3 and Grade 4 students tried out for the team.

Nottingham Grade 4 Chorus and Band will hold their Winter Concert on January 18, 2023, in the Penn's Grove Auditorium at 7:00pm.

Nottingham has some fun spirit days coming up beginning with January 18, 2023, as Workout Wednesday, January 20, 2023, is Tropical Getaway Day, and January 27, 2023 is Fire and Ice (the 3rd graders wear blue and white/the fourth graders wear orange and yellow).

Parent/ teacher conferences are scheduled for February 2, and 8, 2023 from 4:00pm-7:30pm.

Hopewell will be hosting the annual spelling bee from 1:30-2:30 on January 26, 2023.

Hopewell will host a principal's breakfast on January 27, 2023, from 9:00-10:00am.

Thank you to Band Director, Mr. Maule, Choral Director, Ms. Goldschmidt, Orchestra Director, Ms. Hudson, band, chorus, and orchestra students. They did an amazing job at the Hopewell Winter concert. They also spread Christmas cheer in the community as they visited nine community places in which they sang and played Christmas music. Places included the Oxford Fire House, the Oxford Senior Center, OASD District Office and the district schools.

Students received bracelets for showing respect, responsibility and promoting a safe school environment. They also were awarded certificates as part of our School-Wide Positive Behavior program. Thank you to Mr. Mahon and Mr. Thompson for their assistance with this School-wide program.

Penn's Grove had a wonderful winter concert. We are so proud of our musically talented students. They will be holding their School Spelling Bee on Friday, Jan 20, 2023. The last day of Penn's Grove Conferences will be on March 9, 2023, from 4-7:30 p.m. On Friday, January 27, 2023, Penn's Grove will be holding a school wide team building "Amazing Race Day".

Girls Basketball season is completed, and Boys Basketball has just begun.

The Aevidum club at the high school will be hosting a Light Up the Night Dance on January 27, 2023, from 6:00-9:00pm. One hundred sixtynine Senior Post High School Plans letters have been submitted to the school counseling office to date. Scholarships in the amount of \$2.639 million dollars have been awarded through those acceptances. WHEREAS, these local boards have discharged their responsibilities to public education in a manner which has placed public education in the forefront of our educational systems; and

WHEREAS, locally elected officials have distinguished themselves and their communities in this nonpaid, volunteer public service commitment, and

WHEREAS, the contributions of these men and women should be recognized and appreciated by those who benefit from the workings of our public school system;

NOW, THEREFORE BE IT RESOLVED, that the Board of Directors of the Pennsylvania School Boards Association hereby proclaims the month of January as School Board Director Recognition Month in this Commonwealth; and

FURTHER RESOLVED, that this proclamation be communicated to all school districts, school officials and local communities in a planned program which brings visibility and awareness to the role of locally elected school officials to the citizenry of this Commonwealth.

TAX RATE CERTIFICATION RESOLUTION

WHEREAS, on June 27, 2006, the Pennsylvania legislature passed Act 1 of the Special Session 2006, entitled the "Taxpayer Relief Act" (hereinafter "Act 1");

WHEREAS, Act 1 requires school districts to limit tax increases to the level set by an inflation index unless the tax increase is approved by voters in a referendum or the school district obtains from the Department of Education or a court of common pleas certain referendum exceptions;

WHEREAS, Act 1 does, however, allow a board of school directors to elect to adopt a resolution indicating that it will not raise the rate of any tax for the support of the public schools for the following fiscal year by more than its index, provided this resolution must be adopted no later than 110 days prior to the date of the election immediately preceding the upcoming fiscal year;

WHEREAS, the Act 1 Index for the 2023-2024 fiscal year is 5.7%;

WHEREAS, the Oxford Area Board of School Directors has made the decision that it shall not raise the rate of any tax for the support of the General Fund Budget for the 2023-2024 fiscal year by more than its index.

AND NOW, on this 17th day of January 2023, BE IT RESOLVED, That the Oxford Area Board of School Directors hereby makes the following unconditional certifications:

- 1. The Oxford Area Board of School Directors certifies that it will not increase any school district tax for the 2023-2024 school year at a rate that exceeds the index as calculated by the Pennsylvania Department of Education.
- 2. The Oxford Area Board of School Directors certifies that it will comply with the procedures set forth in Section 687, of the Pennsylvania Public School Code, 24 P.S. §6-687, for the adoption of its proposed and final budget.
- 3. The Oxford Area Board of School Directors certifies that increasing any tax rate less than or equal to the index will be sufficient to balance its final budget of the 2023-2024 fiscal year.
- 4. The Administration of the Oxford Area School District will submit the District's information on a proposed increase in the rate of a tax levied for the support of the district to the Pennsylvania Department of Education no later than five days after the Board's adoption of this Resolution.
- 5. The Administration of the Oxford Area School District will send a copy of this Resolution to the Pennsylvania Department of Education no later than five days after the Board's adoption of this Resolution.
- 6. The Oxford Area Board of School Directors understands and agrees that by passing this Resolution, it is not eligible to seek referendum exceptions under Section 333 (f) of Act 1 and is not eligible to request approval from the voters through a referendum to increase a tax rate by more than the index as established for the 2023-2024 fiscal year.
- 7. Once this Resolution is passed, the Administration of the Oxford Area School District is not required to comply with the preliminary budget requirements set forth in paragraphs (a) and (c) of Section 311 of Act I Provided, however:
 - a. The Oxford Area Board of School Directors understands and agrees that, upon receipt of the information submitted by the District as set forth in paragraphs 4 and 5 above, the Pennsylvania Department of Education shall compare the District's proposed percentage increase in the rate of the tax with the index.
 - b. Within ten days of this information, the Pennsylvania Department of Education Shall inform the District

whether its proposed tax rate increase is less than or equal to the index.

Pennsylvania Department of Education c. If the determines that the District's proposed increase in the rate of the District's tax exceeds the index, the District is subject to the preliminary budget requirements as set forth in paragraph (a) and (c) of section 311 of Act 1.
