Students who participated in the "Ask an Astronaut" program were able to have their video presented and their question answered by the astronauts on the Space Station.

PSSA's concluded and were sent to the State today. There were 2,550 students who participated in these assessments. Only 10.5 percent of our families opted out.

Curriculum resources will be updated to the newest version of Math in Focus. The platform changed and teachers have received professional development on the updates.

Two hundred ninety-five students participated in graduation on June 4, 2021. Congratulations to the graduates.

June 17, 2021 will be the end of the school year. Monday, June 21 will be the first day of ESY.

Academies will be held as well as enrichment classes. There are 235 elementary students and 170 secondary students participating in extended learning. There are 112 students participating in academies and 80 students in the extended school year.

REPORTS

Mr. Robinson reported that the CCIU Board met on Wednesday, May 19, 2021 via Zoom.

Dr. Kirk Williard and several staff members presented on career readiness, preparing students to be future ready. Dr. Williard stated that this project really focused on creating new ways to deliver work and career experiences especially throughout the pandemic. Technology integration was an important piece.

A career and training fair, job shadowing opportunities and summer career academies all took place virtually. Through these avenues, the CCIU was able to help in finding vocational training, internships and co-ops for over 200 students.

The CCIU Board of Directors approved the contract and budget in total amount of \$200,000 between the Chester County Department of Community Development and the CCIU. The contract will assess the coverage gaps in high speed internet access in Southern Chester County and offer next steps for mitigating the issues with internet access.

Dr. Owens reported the Legislative Council met and discussed Senate Bill 644 which allows parents to opt in to have their child repeat a year if they feel the child fell behind due to Covid.

SB 733 is out of committee and in the Senate. This would allow vouchers /scholarships, to be used for students with IEP's and GIEP's to use state funds to attend a different school of their choice. There is some concern over private schools being able to provide accommodations to students with special needs as well as the cost to school districts.

SB 1 is an omnibus bill covering items including school funding and charter reform.

The State Budget has still not been passed. The next meeting is next week at 6:30 p.m.


