Five-Year Data And Programming	Dr. Billings-Jones reviewed the historical data of readiness/on core, of incoming kindergarten students in reading and math. Following the students from K through second grade to see the increase in proficiency through the grades. In 2015 State Board of Education approved new PSSA scores. These data changes made the test more rigorous. This changed the percentage of proficient students in the district.
