CCIU Budget Presentation	<p>Executive Director, Dr. George Fiore and Director of Administrative Services for the Chester County Intermediate Unit, Mr. Joseph Lubitsky, presented the preliminary 2021-2022 CCIU Budgets. Mr. Lubitsky stated that the Oxford Area School District's contribution to the Core Budget would not increase. The Occupational Education Budget will increase by 3.8% and the Marketplace Budget will increase by 4.1%. These budgets need to be approved by April 30, 2021 and June 30, 2021 respectively.</p> <p>New to the CCIU this year will be Adult Education programs. This is done in order to assist in retraining adults to meet work opportunities in the face of the pandemic.
