## OXFORD AREA SCHOOL DISTRICT

A nonresident student is one whose parents or legally appointed guardian reside outside the boundaries of the municipalities comprising the Oxford Area School District.

Nonresident students may be admitted to the Oxford Area Schools according to the following policy.

- A. All requests for permission of nonresident students to attend Oxford Area Schools shall be submitted by the parent or guardian in writing to the Superintendent of Schools who is delegated to grant permission consistent with this policy. All requests which are not applicable to this policy will be presented with the Superintendent's recommendation to the Board of School Directors for final action.
- B. The rate of tuition for nonresidents shall be established annually by the Board of School Directors. The amount charged shall be the previous year's actual audited tuition rate plus 10%. Per-student charges shall be calculated separately for elementary grades (K-6) and secondary grades (7-12). All payments are due in the business office in advance and without billing.
- C. Parents who move from the Oxford Area School District during the school year, after the first day of school, who wish to have their child/children finish the year in the Oxford Area Schools, shall be charged tuition at the rate of one-tenth (1/10) the annual rate for each calendar month, or prorated for each fraction thereof from the date of moving.
- D. Graduating senior students (grade 12) will be permitted to attend Oxford Area High School for their senior year without the payment of tuition regardless of when the parents move from the district.
- E. Nonresident students who may be admitted to Oxford Area Schools after the opening of the school year shall be charged tuition at the rate of 1/10 of the previous year's actual audited rate plus 10% for each calendar month or prorated for each fraction thereof for all time of attendance except that a person who anticipates moving into the district during September may, upon application, have the tuition waived for that part of the month prior to moving in. If the parent subsequently moves to the district after September, tuition from the beginning of the school year shall be charged.

- F. Students whose parents move from the school district prior to the end of the school year will be permitted to attend for the remainder of the school year provided that the parents move from the school district during the final quarter of the school year.
  
- G. Nonresidents who are approved for attendance in Oxford Area Schools shall be entitled to all educational benefits which are provided resident pupils and they shall be subject to the same rules, regulations, and policies that apply to resident students. The district will not, however, provide transportation for nonresidents.
